This indenture, quintipartite, made the first day of July, Anno Domini 1676, and in the eighth and twentieth year of the reign of our sovereigh Lod King Charles, the Second, over England, A. & Between Si Cocage Carteret, of Saltrum, in the County of Devon, knight and baronet, and one of his Majesty s most honourable privy Council, of the first part: William Penn of Rickmannsworth, in the county of Hertford, Eng. of the second part. Gaven Lawry London, merchant, of the third part. Nicholas Lucas of Hertford, in the county of Hertford, maister, of the fourth part. and Edward Billinger O'Wainshare, in the county of Madiese, gent of the thirth part. Whereas our all Sovereign of March, in the atheanth year of his axial Majesty's reign, for the consideration therein mentioned, did gives and your unob his devised billing are of his axial Majesty's reign, for the consideration them is maintened.



- For 28 years between 1674 1702, the Province of New Jersey was split in twain, into the Provinces of East and West Jersey.
- There were frequent disputes over borders and authority during this time, especially between the Governor of New York and various leaders of the Jerseys.
- Our research into the history of colonial NJ all began because of one simple, straightforward question:







- Without looking at a map, we kinda just assumed New Brunswick was to the west of the others.

- North Brunswick is south of New Brunswick??

- Seriously why is nobody talking about this?????

# Fort McMyerson West Brunswick New Jersey 08873





Commissioned at the height of WWI, and located on the border of Somerset and Middlesex counties, Fort McMyerson provided continued service straight through the Cold War. It was an integral part of the defense of our country from 1942 until the last of the personal were moved to nearby Fort Dix, in 1990. The base sat, inactive and unused until demolition was started in 2010.

## The Quintipartite Deed

- This deed describes how the British, upon assuming control of the area from the Dutch, split up the province and gave the land to Sir George Carteret (east) and Lord John Berkley (west).

 Almost immediately, disputes as to the exact borders between East and West Jersey cropped up.



Quintipartite Deed of Revision, Between E. and W Jersey: July 1st, 1676

Whereas our said Sovereign Lord the king's Majesty, in anti by his Letters Patents under the great seal of England bearing date the twelfth day of March, in the sixteenth year of his said Majesty's reign, for the consideration therein mentioned, did give and grant unto his dearest brother James. Duke of York, his heirs and assigns all that part of the main land of New England, beginning at a certain place called or known by the name of St. Croix, next adjoining to New Scotland, in America; and from thence extending along the sea coast to a certain place called Pemaquine or Pemaquid, and so up the river to the furthest head of the same as it tendeth northward, anti extending from thence to the river of Kenebeque, and so upwards to the river Canada northward. And also all that island or islands commonly called by the several name or names of Matowacks or Long Island, situate and being towards the west of Cape Codd and the Narrow Higansetts, abutting upon the main land between the two rivers there, commonly called or know n by the several names of Connecticutt, and Hudson's river; together also with the said river called Hudson's river, and all the lands from the west side of Connecticutt river to the east side of Delaware bay; and also all those several islands called or known by the names of Martin's Vinevard or Nantukes, otherwise Nantucket; together with all the lands, islands, soils, rivers, harbours, mines, minerals, quarries, woods, marshes, waters, lakes, fishing, hawking, hunting, and fowling, and all other royalties, profits, commodities and hereditaments to the said several islands, lands and premises belonging and appertaining, with their and every of their appurtenances; and all his said Majesty's estate, right title;, and interest, benefit, advantage, claim and demand of, in, or to the said land and premises, or any part thereof, and the reversion and reversions, remainder and remainders; together with the yearly and other rents, revenues, and profits of all and singular the said premisses, and every part and parcel thereof; to have and to hold unto his said Majesty's said dear brother, the said James Duke of York, his heirs and assigns for ever; to be holden of the King's Majesty, his heirs and successors, as of his majesty's manner of East Greenwich, in his Majesty's county of Kent, in free and common soccase, and not in capite or by knight service, under the yearly rent of forty-beaver skins, to be paid unto his said Malesty his heirs and successors, when they shall be demanded, or within ninety days after, as by the said Letters Patent, relation being thereunto had, it may appear: in and by which said Letters Patent his said Majesty did likewise give and Grant unto his said dearest brother James Duke of York, his heirs, deputies, agents, commissioners and assigns, full and absolute power and authority for the correcting, punishing, pardoning, governing -and ruling such of the subjects of his said Majesty of his heirs and successors as shall at any time adventure themselves into the said ourt and places, or inhabit there, according to such laws, orders, ordinances, directions and instructions, as by his said Majesty's said dearest brother, or his assigns, shall be established; and in defect thereof, in case of necessity, according to the good discretions of his deputies, commissioners, officers or assigns respectively, as well in all causes and matters capital and criminal, as civil, both marine and others, in such manner, and under such restrictions as is therein specified, and to do, exercise and exercute all and every others the powers and authorities therein mentioned, as by the same Letters Patent, and by the several powers and authorities thereby given and granted, and therein specified, it doth and may appear. And whereas, in and by two several indentures, the one being an indenture of bargain and sale for the term of one whole year, and bearing date the three and twentieth day of June, Anno Domini 1664: and the other being an indenture of grant, release or confirmation, and bearing date the three and twentieth day of the same month of June, Anno Domini 1664, and both of them made between his said Majesty's said dearest brother, the said James Duke of York by the name of his Royal Highness James Duke of York and Albany, Earl of Ulster, Lord High Admiral of England and Ireland, Constable of Dover Castle, Lord Warden of the Cinque Forts, and Governor of Portsmouth, of the one part; John Ford Berkley, Baron of Stratton, and one of his Majesty's most honourable Privy Council, and Sir George Carteret of the other part: And by other good and sufficient conveyances and assurance in the law duly executed, reciting the said Letters Patents herein before recited, and the several and respective premises thereby granted; his Royal Highness he the said James Duke of York, for the considerations therein mentioned, did grant, convey and assure to John Lord Berkley and Sir George Carteret, their heirs and assigns forever, all that tract of land adjacent to New England, and lying and being to the westward of Long Island and Manhatan Island, part of the said main land of New England, beginning at St. Croix, mentioned to be granted to his said Royal Highness by the said therein and herein before recited Letters Patent, bounded on the east, part by the main sea and part by Hudson's river; and hath upon the west Delaware bay or river, and extendeth southward to the main ocean as far as Cape May at the mouth of Delaware bay and to the northward as far as the northermost branch of the said bay or river of Delaware, which is in forty one degrees and forty minutes of lattitude, and crosseth over thence in a strait line to Hudson's river in forty one degrees of lattitude; which said tract of land was then afterwards to be called by the name or names of New Caesarea or New Jersey; and also all rivers, mines minerals, woods, fishings, hawkings, buntings, and fowlings, and all other royalties, profits, commodities and hereditaments whatsoever to the said land and premises belonging, or in anywise appertaining, with their and every of their appurtenances. In as full and ample manner as the same w as or were granted to his said Royal Highness the said Duke of York, in and by the said therein and herein before recited Letters Patents; and all the estate, right, title, interest benefit, advantage, claim and demand of the said James Duke of York, of, in, or to the said lands and premises, or any part or parcel thereof, and the reversion and reversions remainder and remainders thereof, to have and to hold unto the said John Lord Berkeley and Sir George Carteret, their heirs and assigns for ever, under the yearly rent or sum of twenty nobles, payable unto his said Royal Highness the said James Duke of York, in manner as the same is aforesaid Herein be paid, as in and by the said last recited indentures and conveyances, relation being thereunto had, may appear. And whereas in and by one certain indenture of bargain and sale dated the eighteenth day of March Anno Domini 1673, and in the six and twentieth Year of his said Majesty's reign, made between the said John Lord Berkeley of the one part, and John Fenwick, of Binfield, in the county of Berks. Esc: of the other part, and duly enrolled in his Majesty's High Court of Chancery in England, recting the said herein before recited Letters Patents, indentures and conveyances, the said John Lord Berkeley for and in consideration of the sum of one thousand pounds therein mentioned, to have been paid unto him by the said John Fenwick, and for other the consideration therein mentioned, did grant, bargain, sell and convey unto the said John Fenwick, his heirs and assigns, all that the moiety or half part of him the said John Berkeley of and in the said tract of land and premises so to be or then called by the names of New Caesarea or New Jersey: And also all that his moiety or half part of all rivers, rivelets, mines, minerals, guarries, woods, fishings, hawkings, huntings, fowlings, and all other royalties, profits, forts, franchises, liberties, governments, powers, priviledges, commodities, hereditaments and immunities whatsoever, to the said land and premises belonging; with their and every of their appurtenances, in as full, ample and beneficial manner to all intents and purposes as the same was granted to the said John Lord Berkley and the said Sir George Carteret, their heirs and assigns, by him his said Royal Highness the said James Duke of York, and all the estate, right, title interest, benefit, property, claim and demand whatsoever, unto the said John Lord Berkeley, of, in, or to the said moiety or half part of the said lands and premises or any part or parcel thereof, by force, virtue or means of the said therein and herein before recited Letters Patents or conveyances, or either or any of them, or otherwise howsoever, and the reversion and reversions, remainder and remainders of the same, to have and to hold unto the said John Fenwick, his heirs and assigns forever, to the only use and behoof of the said John Fenwick his heirs and assigns forever, as by the said last recited indentures of bargain and sale, relation being thereunto had, it may appear. And whereas in and by two other indentures, the one being an indenture of bargain and sale for the term of one whole year, and bearing date the ninth day of February which was in the year of our Lord 1674, and made between the said John Fenwick and Edward Billinge, of the one part, and the said William Penn. Gawn Lawry and Nicholas Lucas of the other part. And the other being an indenture

## Surveyors did their best:

- Over the next 60 years (even after the two halves were reunited), the dividing lines were drawn and redrawn.

- In 1686, Surveyor-General George Keith defined the Keith Line running north-northwest from Little Egg Harbor up north of Tuckerton meeting the Delaware River near the Delaware Water Gap.
- Many minor revisions were tacked onto it over time, resulting in the Thornton Line in 1696, and the Lawrence Line in 1743.

## Maybe I just didn't go to RU, but this was news to me!

- New Brunswick comes first by a large margin!
- The first European settlement in the area was started in 1681, then in 1714 was named New Brunswick.
  - Named after the city of Braunschweig, located in modern Germany.
  - Both King George I and King George II were Dukes of Braunschweig, so it seems the name was chosen to honor one of them. As far as I could tell there was no consensus as to which one it was for! Citation needed, would love to know.
  - Canada's New Brunswick wouldn't exist until 1784.
- North and South Brunswick are first mentioned in the notes of a 1779 Meeting of the Board of Freeholders.
  - That group was renamed to the Board of County Commissioners in 2020. "Freeholder" is a very outdated term.







# A problem..

- North and South Brunswick were folded off from New Brunswick sometime between ~1730 and 1779.
  - We seriously don't seem to know exactly when in that period they were first differentiated. They seem to have developed their own communities/identities naturally over the mid 1700s?

- East Brunswick was actually incorporated **way later in 1860**, with land from parts of North Brunswick, Monroe Township, and Old Bridge!

- So, we're back where we started: Where's West Brunswick?

## **Primary Sources**

- The citation on the first known mention of North and South Brunswick comes down to a book by John Snyder released in 1969.
  - Robert Roe, the then-Commissioner of the New Jersey Conservation and Economic Development Department (what is now the New Jersey Division of Parks and Forestry) described the book as "the most comprehensive of its kind ever published."
  - Surely West Brunswick would be in here.

- A single post mentions the sighting of the artist "Quentin Maribacco" in Macau. This seems irrelevant to everything else on the site.
  - Searching for Quentin Maribacco yields no results anywhere else on the internet.
- They then mention going into Quarantine in March-April 2020.
- Finally, a post appears describing the purpose of the blog.

- In May 2020 they write a post entitled "Adadian"
- They are a Journalism Major at Johns Hopkins, doing research through old primary Revolutionary War documents.
- While searching, they stumbled upon a receipt for a very large transaction of some kind. This was supposedly out to an individual named "Adadian".
- After some days of searching they found record of a book written by someone named Adadian in Tuckerton NJ.
- "In a massive stroke of luck, it was stored in the same library I was searching."
  - Under the Occult, Misc. Section.
- Supposedly what they found was revelatory, but aside from cryptic photos nothing is elaborated on.

This blog with zero views posts two "sponsored" posts, each with an "affiliate" link. We'll get into those later.



Jane posts a missing dog poster. This gives us a real email address. **There's also morse code down the left side.** 

### We finally reach: The Most Important Post

- In June 2020, Jane makes a post: "TRIGGER WARNING. I AM BEING STALKED"
- Apparently, some person made a weird website, and copy/pasted Jane's Twitter profile picture onto it.
- This freaks them out, though they don't discuss how they discovered this.
  - Seriously, who finds un-advertised websites out of the blue
- The website? **mayo nitemare dot com.**

- Punching it in leads to an untitled video entitled "strip" uploaded by user "generatorTURBINE"
- Erin thought she recognized Wingdings, but after some googling she found the real font

### Hmm. We're having trouble finding that site.

We can't connect to the server at www.falidytne.com.

#### If that address is correct, here are three other things you can try:

- Try again later.
- Check your network connection.
- If you are connected but behind a firewall, check that Firefox has permission to access the Web.



### Dead end?

- We weren't really sure where that left us. First, we went back to investigate some of the other links from the blog.
- The two sponsored links to Baron Lapel and Burst Beauty had some strange images which all looked like they lined up.
- We also translated the Lost Dog morse code.







#### Still not much

- While these were interesting they also seemed like answers to puzzles we had yet to encounter.
- We went back to mayonitemare.com, to the only puzzle we hadn't really solved yet.



### NAGARAM

- The puzzle wasn't really that hard, though the creator was generous enough to provide a "key"











#### Derp

- We lost an hour here bc we didn't just think to try all four of them - the codes starting with 1, 2, and 3 all didn't lead anywhere so we thought we were at a dead end again.
- But, finally when we tried the code with a 4...

- None of the puzzles we had solved up until this point gave us these priority codes.
- BUT, we get the name "Fallidyne Corporation", which is similar to "FALIDYTNE DOTCOM" from earlier
- So, on a whim we check out: Fallidyne.com

### Zalgo text?

- Each page on this site has Zalgo text reading

Q:\\ NODE ERROR ERROR CODE 14 Cannot compile Website load faile (sic) Praise Atman

- One page of the site lists a number of companies, one of which was the previously visited Baron Lapel. None of the others had sites we could find.
- In a surprise to nobody, searching for this corporation yields no results aside from this website.

- You click a "Decompile" button a few times which leads you to nearly identical HTML pages "second-contact.html", "third-contact.html", and then "final-contact.html"
- This gives you Priority Codes.
- Man, remember when this presentation was about colonial NJ and West Brunswick?

### In Conclusion

- What the fuck?
- West Brunswick NJ, unfortunately, never existed. The other Brunswicks were all folded off of the once-massive New Brunswick over 150 years after its initial incorporation. It is through the sheer coincidence of the geography and communities that sprung up that the region to the west part of New Brunswick never became distinct enough to warrant their own separate town.
- Some mf decided to put an entire ARG/Cryptic Riddle sequence on the internet, presumably starting with the same question we had?? Perhaps there are earlier steps we missed by skipping straight to West Brunswick??
- It's been around 5 days since submitting the codes and emailing "Jane Warton", and we've gotten no feedback yet. We'll definitely keep everyone informed if we do.

### In Conclusion

- We're left with a long sequence of numbers, the mystery of who "Adadian" is and whether or not he has any relation to the "Atman" mentioned on the Fallidyne website.
- Running WHOIS checks on all of the websites listed here indicates they were all registered by the same "Domains by Proxy LLC" in Arizona, but almost all of them were also built using a piece of software called Adobe Muse, which is a very unorthodox way to build a website.
  - These two facts together indicate all of these sites were put together by the same person/organization. (Not that that should be terribly surprising)
- To ensure I wasn't missing anything, I ran a web scraper over all of the websites in question. It didn't pick up anything we hadn't already found.





Certainly the least well known of the Brunswick's, West Brunswick is a town filled with rich history, and beautiful expanses. Thank you for coming here to learn more.
